Sl. No.	GENERAL CONDITIONS
1.	The total number of section of the school shall be restricted to 18 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
2.	Compliance of the points no. 1 to 4 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.
Sl. No.	CONDITIONS FOR COMPLIANCE
1	The maintenance of Library, Science Labs, class Rooms, toilets and other infrastructure seems to be not satisfactory. Hence, the school is required to maintain enriched Library, equipped Science Labs., clean toilets and other infrastructure as per specification mentioned in the Affiliation Bye-Laws, 2018.
2	The school is required to appoint regular & qualified PETs/PTI and other staff as per norms.

3	It will be the responsibility of the school to ensure availability of pucca boundary wall at sufficient height round the school campus being a mandatory rule of Affiliation Bye-Laws, 2018
4	The number of sections in the school are restricted to 18 sections as per the availability of classrooms. For classroom size between 400 to 500 Sq. feet, the students shall be restricted to 32 candidates per section and sections shall not be increased without prior approval of the Board. Further, the School is directed not to use classrooms size less than 400 Sq. feet.

The above is subject to fulfillment of the following conditions:-

1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school to renew mandatory certificates from time to time.
6. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.




